## The Right to Social Security in the Constitution of the Bolivarian Republic of Venezuela

This article summarises a more extensive study of the process which culminated in the inclusion of the Right to Social Security in the new Constitutional text. Amongst the antecedents, the author analyses the tradition of social constitutionalism prior to 1999 and the different Pre-Projects submitted to the National Assembly for its consideration. An analysis of Article N° 86 allows the author to identify the institutions and precepts on social security which ought to prevail in the elaboration of the Organic Law on Social Security and which are offered in the Pre-Project presented by the Federación de Asociaciones de Profesores Universitarios de Venezuela (FAPUV), the Asociación de Profesores de la Universidad Central de Venezuela (APUCV), the Postgraduate Studies in Social Security (FACES-UCV) and the Fondos de Jubilaciones y Pensiones de las Universidades Nacionales.

## The Victim and Venezuelan Penal Justice from the Perspective of the victim Maria Josefina Ferrer

This article examines the rights and the obligations of the Victim in the functioning of the Venezuelan judicial system. It stresses the importance of defining the different categories of victims recognised in the Venezuelan legislation and notes that these are inevitably related to the complementary definitions of 'crime' and 'criminals', precisely because it is within the framework of the penal process that some victim's rights have been recognised. In this sense, the author confesses that the notion of 'victim' is being used in a restricted sense, which is derived from its legal definition. She underlines the importance of those victim rights which have been legally recognised but argues the need to advance, if this formal recognition is not to remain merely symbolic. The article concludes suggesting that currently there is no effective guarantee of the rights to retribution and protection and that, as a result, one of the three basic objectives of the judicial process (COPP: Arts. 13 and 115), are not realised and, as ever, the victim is victimised.

### A Procedure for Quantifying Qualitative Variables Based on the Principles of Reciprocal Averaging and Homogeneity Analysis

This article proposes a methodology for quantifying qualitative variables. based on the concepts of Reciprocal Averaging and Homogeneity Analysis, as a preliminary phase in the eventual construction of an indicator which the authors have called the Synthetic Poverty Index. The need to quantify arises because the variables used in measuring poverty are of a 'categorical' type and are thus not susceptible to analyses based on the most efficient statistical methods for the construction of indexes. The formal aspects of the Optimum Quantitative Valoration are discussed and the authors offer an example in which they quantify an index of 'the quality of life' from the perspective of its relation to the classes defined by the Poverty Line Method, with the result expressed in a typology of homes ordered in terms of a gradient of social stratification.
