## **PARA LA PRESENTACION DE ORIGINALES**

Autor: Apellido completo e inicial del nombre separados por coma. Desde la segunda vez en adelante sólo Apellido. En ambos casos seguido por coma.

Título de libros y revistas: En cursiva.

Título de los artículos aparecidos en revistas, de ensayos publicados en obras colectivas, de capítulos o partes de libros:

Entre comillas « ».

Entre los diversos datos: Puntuación únicamente con comas.

Para los libros, indicar a continuación: Lugar de edición, editorial, año de edición, eventualmente el año de la primera edición entre paréntesis.

Para las revistas y toda publicación periódica, indicar a continuación número del volumen, seguido por año entre paréntesis, tomo y número o fascículo. Además, si la revista no es conocida, póngase después del título, entre paréntesis, el nombre de la ciudad e institución donde se publica.

Abreviatura de páginas: p. (si una sola), pp. (si dos o más), p. y ss. (si se reenvía a una parte).

Volúmenes o tomos: Indicar en forma abreviada "vol." o "t." seguido del número romano.

Para las notas, si se trata de una cita textual, póngase directamente autor, título, etc.. Si se trata de una referencia, póngase Cf. Autor, título, etc. Lo mismo vale para un texto ya referido.

Si la nota que sigue hace referencia al mismo autor y al mismo ensayo u obra, póngase sólo *Ibidem* (en cursiva), si se trata de la misma página; *Ibid.* seguido de coma y p. ó pp. y número de la página o páginas, si ésta es diferente.

Si el texto que se cita está en un volumen que recoge varios ensayos o en una obra colectiva, se pondrá la preposición 'en' seguida del apellido e inicial del nombre y, entre paréntesis, (Ed.) o (Coord.). Si el autor del artículo y el editor o compilador coinciden, póngase (*Id.*).

Cuando se vuelva a citar un texto ya identificado, póngase el apellido del autor, el título abreviado (las tres primeras palabras) seguido por ..., cit., y las páginas.

Eventuales bibliografías irán por orden alfabético de apellidos.

Las citas deben estar insertadas en el texto y entre comillas. Si tienen más de tres líneas, pónganse como nuevo párrafo, con un reducido espacio entre los renglones, en letra un punto más pequeño y dejando tres (3) espacios en los dos márgenes.

Para indicar omisión de palabras o de pasajes: póngase tres puntos entre corchetes [...].
